ORDER:

In the letter 2nd read above, the Director of Medical Education, A.P., Hyderabad, has reported that, a Committee has been constituted for preparation of the list of inadmissible medicines regarding sanction of Medical Reimbursement to the Government Employees/Retired Employees as well as All India Service Employees, MLA's etc, who are eligible for reimbursement under APIMA Rules, 1972. After thorough discussions with the doctors of various specialties and experts in consultation with Drug Control Administration and CGHS authorities and the Committee has prepared the final list of inadmissible medicines.

- 2. Government after careful examination of the matter has decided to approve the Inadmissible medicines prepared by the Committee.
- 3. Accordingly, the following list of Inadmissible Allopathic medicines and other preparations under Appendix-II (Vide Rule 5(3)(i) of Part.I of APIMA Rules, 1972 is hereby approved:-
 - 1. The list of Allopathic inadmissible Medicines and other preparations classified in Schedule I to IX under different broad categories may be treated as illustrative only indicating their ineligibility for the reimbursement.
 - 2. The Authorized Medical Attendant/Scrutinizing authority of Medical reimbursement claims may take a decision whether a particular medicine or preparation falls under any of the broad categories classified in Schedule I to IX and shall so certify whereupon the cost of such medicines/preparations may be reimbursed.
 - 3. No references as to the admissibility or otherwise of Medicines / preparations will be entertained by the Health, Medical and Family Welfare Department, Government of Andhra Pradesh.

SCHEDULE - I I

FOOD AND FOOD PREPARATIONS

FOOD, FOOD SUPPLEMENTS and Foods Fortified with Essential Amino Acids, Essential Fatty Acids, Essential Minerals, Glyconutrients, Phytonutrients, Vitamins and other ingredients are inadmissible.

Alcohol based preparations, baby foods, carbonated/flavoured/ sweetened beverages, glucose, liquid foods, Malt preparations, meat extracts and juices, Protein preparations, Salt substitutes; Vegetable and plant preparations, Weaning foods, wine and other similar kind of Food Preparations are inadmissible.

SCHEDULE - III

COSMETICS, TOILETRIES AND OTHERS

LIST-A

COSMETICS: as defined under The Drugs and cosmetics act, 1940 and The Drugs and Cosmetics rules, 1945 of Ministry of Health and Family Welfare, Govt. of India are inadmissible. For example: Baby Products, Bath Oils, Butter, Contact Lenses, Deodorants, Hair Colors, Lotions, Powders, Perfumes, Skin Care creams, and similar kind of products and preparations are inadmissible.

LIST - B

TOILETRIES: For Example : Cleansing wipes, Colognes, Cotton Swabs, Deodorants, Lip Gloss, Lubricants, Lotions, Makeup material, Mouthwash, Nail Polish, Perfumes, Razors, Shampoos, Shaving Cream, Skin Cream, Tissue Paper, Toilet Paper, Tooth Brushes, and Toothpaste and similar kind of products and preparations are inadmissible.

LIST - C

Disinfectants, Antiseptics, Hygiene Products, Emollients, Liniments, Sanitizers and similar kind of products and preparations are inadmissible.

SCHEDULE - IV

Drugs & procedures used to treat **infertility** are inadmissible.

SCHEDULE -V

MEDICAL DIAGNOSTIC AND THERAPEUTIC EQUIPMENT: Like Blood Pressure Monitors, Blood-Glucose Monitors, clean room equipment, Clinical Thermometers, Cylinders containing Oxygen and other medical gases and its accessories, Dialysis Machines, diagnostic equipment, Electrical Defibrillators and stimulators, Footware, Hospital furniture, Hospital Beds and Mattresses, infant radiant warmers, infrared and ultra sound equipment, Equipment used for inhalations, Massage equipment, Medical sterilization equipment, Nebulizers, Neonatal incubators, Pulse Oxy-meters, Spectacle frames, sun glasses, Stethoscopes and other similar kind of products and materials are inadmissible.

SCHEDULE - VI

DISPOSABLE AND CONSUMABLE ITEMS:

Like Aprons, Bandages, Caps, Catheters, Collection bags and containers, Cotton, Diagnostic strips, catridges and kits, Diapers, disposable syringes, disposable needles, elastic crepe bandages, Gloves, Gowns, linen, Masks,

McIntosh sheets, surgical dressing material and other similar kind of Disposables and consumables are inadmissible except when used for Inpatient treatment.

SCHEDULE - VII

Fitness and Physiotherapy equipment are inadmissible.

SCHEDULE-VIII

Miscellaneous charges:

Like Ambulance and transportation charges Admission Charges, Attendant Pass charges, Charges Collected for medico legal cases, medical records and Registration, Diet charges, Diet Counseling charges, Hospital Administration Charges, Luxury Taxes, Psychiatry counseling charges and behaviour counseling charges are inadmissible.

SCHEDULE - IX

EXPENSIVE DRUGS

For which cheaper substitutes of equal therapeutic value when available are inadmissible except when prescribed and certified by the treating specialist doctor.

The Director of Medical Education, A.P., Hyderabad and other designed scrutinizing authority shall take necessary action in the matter accordingly.
