ORDER:-

The Government have examined the proposals of the Director of Medical & Health Services and die Senior Deputy Accountant-General

(Accounts), to make certain amendments to die Andhra Pradesh Integrated Medical Attendance Rules, 1972. After careful examination of die proposals, the Government direct that the following amendments be issued to the Andhra Pradesh Integrated Medical Attendance Rules, 1972:

AMENDMENTS

(1) The following note shall be added under role 5 (2) of the Andhra Pradesh Integrated Medical Attendance Rules, 1972:

"Note: Wherever a Government Servant consults Authorised an Attendant/Specialist in the fetter's consulting Room and medicines were prescribed, the Medical Officer of the Secretariat Dispensary is authorised to issue medicines to the Government servant and their families on the prescriptions given by the Authorised Medical Attendant, Specialist although they are not attached to the Secretariat Dispensary. In case the medicines prescribed by the Authorised Medical Attendant/ Specialist are not available even at the Secretariat Dispensary, the Government Servants may purchase the medicines outside and get the amount spent there by reimbursed later as per rules. The Medical Officer, ordinarily bound to purchase and supply the medicines. He Secretariat Dispensary, is not will, however, stock all the necessary medicines in the dispensary to meet the requirements."

(2) The following note shall be added under rule 5(3) (iii) of the said rules:

"Note: Bills for small amounts upto Rs. 15/- at a time need not be countersigned by the authorised Medical Attendant. In such cases. Essentiality Certificate should specifically mention the names and quantum of medicines required. Also, that certificate should be marked as cancelled while the bill is submitted so that it cannot be used again."

- (3) In rule 10 (2) of the said rules, after the words "The Government servants of this State" and before the words "Residing outside the State", the words "and their families shall be inserted.
 - (4) The following note shall be added under rule 10 (2) of the said rules:

"Note: The Government recognise the All India Institute of Medical Sciences and Wellingdon Hospital, New Delhi, for treatment of the employees of Andhra Pradesh and the members of their families at New Delhi, and also those visiting. New Delhi."

- (5) After rule 21 of the said rules, the following shall be added as rule 22:
- "22. These rules shall come into force from the date of their issue on 6-4-1972. All other rules and orders on-the-subject, issued prior to the date of coming into force of the Andhra Pradesh Integrated Medical Attendance Rules, 1972, shall stand repealed from the date of their coming into force on 6-4-1972."
- (6) After sub-rule (ii) under rule 2 in Appendix, III of the said rules, the following shall be added.
- iii)For District Medical reimbursement bills, if any doubt arises, the medical reimbursement bills other than those pertaining to the Municipal limits of the District Headquarters should be referred to the District Medical & Health Officer concerned, and for the bills arising within the Municipal limits of District Headquarters to the Superintendent of the District Head quarters Hospital concerned."
- (iv) In twin cities of Hyderabad and Secunderabad, if any doubt arises the medical reimbursement bills araising within the municipal limits of Hyderabad and Secunderabad should be referred to the Superintendent, Osmania General Hospital Hyderabad/Gandhi Hospital, Secunderabad, respectively."
- (v) With regard to the authority to pass the medical reimbursement bills, the authority competent to countersign the T.A. Bills of Ac individual is me authority to pass the medical reimbursement bills for me Gazetted and Non-gazetted employees.
- (7) The existing rule (4) in Part-1 of Appendix-VI of the said roles, shall be substituted by the following:
- (4) The advances shall be treated like advances of Travelling Allowance and by on transfer and the recovery must be effected by adjustment from the claim for reimbursement of medical expenses."
- (8) For me figure "Rs. 30/-" occurring in role (11) of Part-1 in Appendix-VI of the said rules, the figure "Rs. 50f-' shall be substituted.
