It has been brought to the notice of the Director of Medical Education, Telangana through the reference 1<sup>st</sup> cited, that the Smt.P.S.M.Vijaya Principal Nursing Tutor (Under Suspension), Government School of Nursing, Gandhi Hospital, Secunderabad was convicted in CC.No.3971/2019 in calendar case NI Act No. 3971/2019 for the offence punishable under section 138 of NI Act and sentence to under go simple imprisonment for a period of one month with directions to pay Rs. 1,50,000/- towards compensation under section 357 (3) of criminal procedure code.

Thereby she is found in violation of Rule – 20 of Telangana Civil Services Conduct Rules 1964, as a proved case of moral turpitude. Hence, it is provisionally decided to impose a penalty of dismissal from services w.e.f. date orders of conviction in terms of Government Order in references  $6^{th}$  and  $7^{th}$  cited.

In view of the above, Smt.P.S.M.Vijaya Principal Nursing Tutor (Under Suspension),, Government School of Nursing, Gandhi Hospital, Secunderabad is hereby directed to show cause, as to why a penany of dismissal from services shall not be imposed. She has to submit explanations if any, by attending personally to the office of Director of Medical Education, Telangana within (15) days from the date of issue of this notice, failing which it will be construed that she has no explanation to offer and she shall be dismissed from Government Service.
