IMPORTANTPOINTS

- **The Examination applications of the students and INTERNAL ASSESSMENT MARKS should be uploaded in the DME official Web site (<http://dme.telangana.gov.in>) and the same will be available from 14.10.2025 to 23.10.2025 (without late fee) and late fee from 24.10.2025 (with late fee)**
- **No institution shall submit average internal marks of the total students more than 75% i.e., if 40 students are admitted in a course the average score of the 40 students shall not exceed 75% of total internal marks as per the INC regulations. Hence, keeping in view of the above provision, submit the internal marks through online.**
- **Then, takeout the Printout of the application forms, then enclose the examination fee of the students of Nursing School (Original Challans) along with required documents to the application i.e., Attendance of theory and Practical etc., (Details are available in Annexure-I) should be submitted directly to the scrutinizing centers mentioned against their School of Nursing in the above statement on or before 25.10.2025 by 5.00P.M. Applications will be accepted with late fee of Rs. 100/- per candidate in addition to existing fee of 1st, 2nd and 3rd years on 24.10.2025 by 05.00 PM. After last date of late fee i.e., 24.10.2025 examination applications and fee will not be accepted.**

- The Superintendents of the Teaching Hospital/Principal of the Government schools of Nursing of the concerned Scrutinizing centre are directed to accept the examination applications as per the dates mentioned above strictly and scrutiny has to be done as per the instructions given in the notification and as per the INC rules & regulations and submit the scrutinized applications of their securitizing centre in Nursing Education Section, O/o. Director of Medical Education, Telangana State, Hyderabad is 03.11.2025 by 5.00 PM. All the scrutiny of applications should be completed at the centers level itself. No manual applications are entertained.
- **The Principals of Govt./Private Schools of Nursing are directed that, they have to enclose the Attested photo copies of the Mark lists of the previous years and downloaded marks lists of Exams to the Examination applications. Without this, the applications will be rejected. Further, they have to enclose a certificate to the examination application, from the concerned teaching and other hospitals stating that the students have completed the required clinical hours.**

Further, the Principals of Govt./Private Schools of Nursing should also follow the following instructions scrupulously.

- 1) All the applications should have the enclosures as noted in the application form. The Incomplete and incorrect applications will be rejected at the scrutinizing centers only. The subsequent additions of the documents to the application to the DME will not be entertained at DME at any cost.
- 2) Important Instructions regarding 1st and 2nd year subjects: The Principals of Government and Private Schools of Nursing are informed that, as per the instructions of the Indian Nursing Council, the students who failed in 1st year and 2nd year subjects belongs from 2015-16 academic year onwards (i.e., New Syllabus) either in Theory and Practical examination, they have to appear for both Theory and Practical in next Supplementary exam. Even if a student is absent in Theory or Practical separately, He / She has to appear for both Theory and Practical exam.
- 3) All applications of New Regulations (NR-2) students have to be submitted in Color Printed form. Black and White application copies will not be accepted.
- 4) As per the examination schedule, the candidates should produce their practical Record at the examination center concerned.
- 5) The Principals of Government and Private Schools of Nursing are informed that necessary instructions may be given to their students concerned that while filling up the Application form Online.
- 6) THE PRINCIPALS OF SCHOOLS OF NURSING ARE INFORMED THAT HALL TICKETS WILL BE ISSUED ONLY TO THOSE SCHOOLS THAT ARE FOLLOWING INDIAN NURSING COUNCIL REGULATIONS, NEW DELHI.
- 7) All Private Schools of Nursing are instructed to submit the Attendance Certificate for both theory and Practical's of the students of their concerned Schools of Nursing along with hard copy of the examination applications to the concerned Scrutinizing centers. They are also informed that, unless the internal Assessment marks are uploaded, the applications will not be accepted for uploaded through online.

They are also informed that if any student fails in Internal Assessment Marks of any subject such student is not allowed to write the examination for that subject only. In such a case, caution to be taken while filling up of the application for appearing other subjects.

- 8) The students who are not eligible for final BEGNM Examinations as per INC norms like i.e., shortage of Attendance etc. such applications should not be submitted to the scrutinizing centers.
- 9) The Head of the examination center concerned is requested to depute responsible officials to collect the Examination Material on **14.11.2025 and 15.11.2025** and for Hall tickets from the O/o.DME on **14.11.2025 and 15.11.2025** before **3.00 PM**.
- 10) The Chief Examiners of the Examination Centers located in twin cities are requested to send the Answer Scripts of Theory papers immediately on completion of the examination every day and other centers located in Districts should submit the Theory answer scripts on **09.12.2025** and practical answer scripts along with Marks sheets and attendance sheets should submit at BEGNM office on **09.12.2025** without fail with proper sealing. The Chief Examiners of the Examination Centers are informed that he / she should super scribe the Register Numbers of the Answer Scripts packed in the Bundles. Any deviations in the submission of Answer scripts will be viewed seriously.
- 11) The Chief Examiners of the Examination of the examination centers are requested to submit the record of attendance (Subject wise) in separate cover in original of all the students who appeared General Nursing and Midwifery, Regular Examinations, **November, 2025** otherwise, the Answer Scripts will not be received without original record of attendance.

All the Principals of Government Schools of Nursing / Correspondents of Private Schools of Nursing are informed that the examination will be conducted in the Govt. Schools of Nursing / Teaching Hospitals and in private schools of nursing in the state.

Note:-

All the Principals / Correspondents / Secretaries of private nursing institutions are directed to submit their approved list of the selection candidates for the academic year 2024-25 in original to the DME office before collection of the hall tickets. No hall tickets will be issued unless until receipt of the approved list.

Further, they are informed that, the Hall tickets for the eligible candidates to appear for the examinations will be uploaded in the Director of Medical Education official website. Hence, they have to download the Hall tickets and affix the same photograph which was already affixed in the examination application form and signed by the Principal across the photograph and the same may be issued to the candidate. The schedule for downloading the Hall tickets will be intimated later through website.

ANNEXURE-I

IMPORTANT POINTS TO BE FOLLOWED WHILE SUBMISSION OF GENERAL NURSING AND MIDWIFERY APPLICATIONS.

- General Nursing & Midwifery Examinations, November, 2025 (Regular) downloaded applications has to be submitted at the Scrutinizing centers only noted against them in the notification. No applications will be accepted at the O/o. Director of Medical Education, Telangana State, Hyderabad under any circumstances.
- Date for payment of fee and submission of online applications is from 14.10.2025 to 23.10.2025 and the downloaded applications should be submitted to the scrutinizing centers on or before 25.10.2025.
- Last date for payment of late fee of Rs.100/- per application will be accepted on 24.10.2025. Submission of applications at the scrutinizing centers on or before 25.10.2025 by 5.00 P.M.
- Internal assessment marks should be uploaded through online only. Otherwise, the applications will not be accepted through online.
- Separate challans should be made for all students of 1st, 2nd and 3rd year students (year wise challans) along with the list of candidates appearing for examinations year wise.

Eligibility to the Examination

- Candidates who are promoted / passed in the 1st year examinations, they have to complete 11 months training for appearing 2nd year examinations.
- No candidate is allowed for appearing for 1st & 2nd year subjects along with 3rd years examinations and backlog subjects in the previous years while appearing for 3rd year examinations.
- They have to enclose the attested photo copies of the marks lists of the previous years and downloaded marks lists of previous examinations to the examination applications. Without this, the applications will be rejected.
- They should enclose the attendance of theory and practical of the students to the examination applications.
- **Candidates who are admitted in 2019-2020 batch is the last chance to appear BEGNM examinations as per INC Norms (6 years period) i.e. the Hall Ticket No. starts from eq: 2020012345.**
- **The correction of names or initials or father names on hall tickets cannot be considered after issue of hall tickets. Hence, be aware of candidate details before filling of the examination application form.**
- The Hall tickets for the eligible candidates to appear for the examinations will be uploaded in the Director of Medical Education, Telangana State official website. Hence, they have to download the Hall tickets and affix the same photograph which was already affixed in the examination application form and signed by the Principal across the photograph and the same may be issued to the candidate. The schedule for downloading the Hall tickets will be intimated later through website.

- Verify the applications of 1st year with the following original documents for regular students if any:
 - 1.SSC /10th class marks memo.
 - 2.Intermediate marks memo.
 - 3.Transfer certificate.
 - 4.Migration certificate for the students of outside Telangana State.
 - 5.To verify the students names with the selection list . The selection list should contain the signatures and stamps of all the committee members, such lists are only accepted.
 6. Signature of the student on the application.
 7. Photos on the applications with the signature of the concerned school Principal and with seal.
 8. All the copies of the certificates should be attested by the concerned Principal of School of Nursing and enclose to the application.
- Verify the applications of 1st year with the following original documents for Supplementary students:
 1. First year previous marks memos/downloaded marks memos.
 2. Signature of the student on the application.
 3. Photos of the students on the applications with the signature of the concerned school Principal with the seal.
- To verify the applications of 2nd year with the following documents:
 - 1.1st year marks memos
 2. Signature of the student on the application.
 3. Photos on the applications with the signature of the concerned school Principal and with seal properly
- 1. To verify the applications of 3rd year with the following documents:
 - 1.1st and 2nd year marks memos.
 - 2. Signature of the student on the application.
 - 3. Photos on the applications with the signature of the concerned school Principal and with seal.
- 4. There should be no backlog subjects of 1st and 2nd years for appearing 3rd year GNM Examinations.
- The Principal, Government School of Nursing is requested to scrutinize the applications as per the Eligibility of the candidates as noted in the Annexure-I
- Rejected applications need not be submitted to the O/o Director of Medical Education, T.G, Hyderabad and the same may be returned to the concerned school of Nursing at the scrutinizing center only.
- The Principal, Government School of Nursing of the concerned Scrutinizing centre is held responsible for any deviation and lapses in the scrutiny of the applications.
- **** Manual Applications should not be accepted.
- **Note:-** Scrutiny of all the applications should be done in scrutinized centers only. No further scrutiny of applications will not be entertained at D.M.E Office.

4. For New regulations 1st year regular candidates, the application form opens and a Application number is generated which can be obtained in the printout. This number can be used for taking out any subsequent printouts.
5. For 1st year regular students while entering their names only name should be typed as per SSC record only and prefix like Mr. /Mrs./Miss./ Kum. Should not be typed.
6. All the blanks in the application form should be filled up to obtain a printout. There is no provision for editing. Hence, the School authorities are instructed to be careful while typing the particulars in the on-line form.
7. Entry of Internal Assessment marks in the online is compulsory; otherwise applications will not be accepted through online.
8. For opening the application form for all 1st year Supplementary, 2nd year regular & Supplementary and 3rd year regular & Supplementary candidates you should enter the Hall ticket Number allocated earlier.
