All the Regulatory Authorities namely the Registrars of Universities, the Secretary, Board of Intermediate; the Director of Technical Education, the Director, School Education; Secretary, Para Medical Board, the Director, Medical Education, and all the Welfare Officers in the State of Telangana are invited to the reference cited, wherein certain instructions have been issued for registration of Colleges and verification of students in e-pass system to enable process the data of students who are admitted under Convener Quota through CET for sanction of Post Matric Scholarship.

- The registration of Colleges and Students for the Academic Year 2025-26 in e-pass website has commenced from 01st, July, 2025 and is going to ceased on 30th September, 2025.
- The Commissioner, SCDD, TS, Hyderabad has reported that so far, only (1,74,004) Renewal registered against (7,12,900) and only (30758) Fresh registered against (4,57,993). The Conveners of EPCET, EAPCET (Pharmacy), ECET, CPCET, DIETCET, EDCET, ICET, KLNR, LAWCET, PGECET, AGRICET, PECET, NATA & SW2 have not yet finalized Counseling and not uploaded in the epass portal and CET data is required for Registration of Post Matric Scholarship by Students for fresh registration of Students vide reference cited.
- 4. The Commissioner, SCDD, Hyderabad has therefore requested the Government to extend the last date upto 31.12.2025, so that all the eligible students and colleges are registered for the academic year 2025-26.
- After careful consideration, Government hereby permit to extend the last date upto 31.12.2025, for Colleges and Students registrations in epass website for sanction of renewal and fresh scholarships for the academic year 2025-26, so that all the eligible students can register for the academic year 2025-26.
- All the Regulatory Authorities and College Managements must ensure that all Colleges & Students who wish to register in e-pass will upload their data upto 31.12.2025, for sanction of renewal and fresh Scholarships for the Academic Year 2025-26.
- 7. All the students who are contemplate to get the benefit of Scholarships must visit the e-pass website at http://telanganaepass.cgg.gov.in and upload their data to register in e-pass website for sanction of fresh and renewal Scholarships.
- All the Welfare Departments must give wide publicity on the Registration process for Scholarship renewal and fresh Scholarships to Students and College Managements and ensure that the registration process be completed by 31.12.2025.
