Applications are invited from the eligible candidates for the posts of Medical Officer / Allied Health Services / Administration & Support staff on Contract on purely temporary basis for a period up to 31.03.2027 or till actual need ceases or till the regular posts are filled up whichever is earlier to work at TIMS, Sanathnagar under the administrative control of the Director of Medical Education, Telangana State, Hyderabad.

Terms & Conditions:

1. The appointment as contract employee is purely on temporary basis up to 31.03.2027, or till the vacancies are filled by promotion/regular appointment or till the actual need ceases whichever is earlier. This contract placement does not confer any right for future Government appointment.
2. For the posts of Junior Assistants Preference will be given to the local candidates of Hyderabad District, if local candidates are not available, other candidates will be considered.
3. For other posts i.e., Allied Services, Administrative and Supporting staff the upper age limit is 45 years with relaxation of 5 years for SC / ST candidates and 3 years for BC Candidates.
4. The selected candidate will have to submit the relieving order from their previous Institute, if he/she is already working any other Institution, failing which their selection will stand, cancelled.

5. The candidates who have joined and working in any other Government Medical Colleges of Telangana on Contract basis in same cadre are not eligible to Apply.
6. During the period of contract, the faculty will be paid a consolidated monthly remuneration depending upon the post as per GO. Ms. No. 49, Finance (HRM. VII) Department dated 21-05-2026.
7. The remuneration shall be all inclusive and subject to deduction of tax at source and/ or any other statutory deductions to the extent required under the laws.
8. Rule of reservation will be followed as per Government norms.
9. The selected faculty will be eligible for 15 days of leaves in a calendar year on cumulative basis as per existing norms.
10. If the selected candidate has not joined within the stipulated time, then the next eligible merit candidate will be selected.
11. The contract is liable to be terminated at any time, without assigning any reason. Similarly, the selected faculty may also terminate the Contract any time with one-month prior notice.
12. The engaged faculty will be under the administration control of the institute on whole time basis and his/her service may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional Remuneration.
13. The Application form will be available at DME website www.dmetelangana.com. A Filled in applications should be submitted along with Xerox copies of documents mentioned below on the day of interview and individual should carry all original Certificates also.

 - g) MBBS Registration from Telangana State Medical Council, additional PG Qualification registration from Telangana State Medical Council only. (Without registration application will be rejected) ** non-local candidates should get their qualification registered from Telangana State Medical Council within one week of selection, for their appointment to be confirmed.
 - h) Copy of experience certificate from State Government Hospitals / Institutions / Programmes on contract / outsourced basis of appointments.
 - i) The Original Certificates of the selected candidates have to be submitted at the time joining, and will be under the custody of DME TG Hyderabad.

Applications which are not properly filled up or without necessary Enclosures will be summarily rejected and postal delay will not be considered.

15. Selection Criteria:

A) Selection will be made as follows:

1. 70% Marks will be calculated for the Education Qualification / Qualified Exam
2. 30% Marks will be added for the experience as weightage for the contract/
Outsourcing services rendered in any Government Institutions as below:
 - a) 2.5 points for 6 months period for who worked in Tribal Area.
 - b) 2 points for 6 months period other than Tribal Area

Note:

1. The experience points to be given only the completed period of (06) months
2. The experience certificate should be submitted in the prescribed form of 1b/1c and should be signed by the competent authority.
